



GDPR Privacy Notice

GertLug members Group thanks you for joining our group and for your confidence and interest in our membership services. Safeguarding your personal data and therefore protecting your individual right of self-determination is very important to us. We want you to feel secure when you visit our website or pass personal information to one of our committee members and we comply with all aspects of the UK's data protection legislative framework, which includes the European General Data Protection Regulation (GDPR) and the Data Protection act 2018.

In this privacy notice, we provide you with an overview of what information we collect from you, as members of GertLug, and how this data is used. We also tell you about your privacy rights and how the law protects you. In addition, you can find a specific privacy policy on our website which governs our use of data when you visit GerLug online.

It is important that you read this privacy notice together with any other privacy notice we may provide on specific occasions when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your data. This privacy notice supplements the other notices and is not intended to override them.

What Data do we collect?

- Personal Identification information (Name, postal address, email address, telephone/mobile number).

How do we collect your data?

You directly provide GertLug with most of the data we collect. We collect data and process data when you:

- Register for membership and complete our membership form.
- Voluntarily complete a survey or provide feedback on any our digital message boards, at GertLug organised events such as Brick shows or monthly meet up's and/or via email.
- Use or view our website via your browser's cookies (please refer to specific GertLug website Privacy policy displayed on our website).

How will we use your data?

Our organisation collects your data so that we can:

- Process and manage your membership account (including recording membership fees status) as-well as manage our register of members.
- Email you with specific promotional, informational or other offers from time to time that the organisation is undertaking.
- Contact you directly to your postal address, where applicable, such as delivery of your welcome brick upon joining the group and other promotional materials from time to time.

When our organisation processes your data we may from time to time also send it to a 3rd party organisation (such as Brickshow venue) if named vendors/displays are required for legal compliance (such as insurance documentation).

How do we store your data?

Our organisation securely stores your data digitally on Microsoft network files on committee member IT equipment and physically (if applicable) within the residential homes of the relevant and responsible committee member.

Our organisation will keep your personal data for the duration of your membership with us and for a period of no more than 1 year in the event you wish to terminate your membership. Once this time period expires we will delete all data associated with your membership account.



Marketing

Our organisation would like to send you information, from time to time, about our products and services that we think you might like.

You have the right to opt out of receiving marketing information directly from Gertug at any time.

If you no longer wish to be contacted for marketing and similar information update activities then please contact us directly (email address provided at bottom of notice).

What are your data protection rights?

Our organisation would like to make sure you are fully aware of your data protection rights. Every member is entitled to the following:

The right to access – You have the right to request our organisation for copies of your personal data. We may charge you a small administrative fee for this.

The right to rectification – You have the right to request that our organisation correct any information you believe to be inaccurate. You also have the right to request our organisation complete information you believe is incomplete.

The right to erasure – You have the right to request our organisation erase your personal data, under certain circumstances.

The right to restrict processing – You have the right to request that organisation restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our organisation's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that our organisation transfer the data that we have collected to another organisation, or directly to you, under certain circumstances.

If you make a request (called a Subject access request or SAR) we have a period of 1 month/30 days to respond to you in line with legislation. If you would like to exercise any of these rights please write to us at:
